

HIRING OF SERVICES OF HVAC CONSULTANTS

The University of Agriculture, Faisalabad intends to hire the services of VRF/VRV HVAC (Heating Ventilation & Air-Conditioning) Consultant in terms of Rule 44 and 45(2) of Punjab PPRA Rules 2014.

The Scope of Work comprises of Complete Drawing and Design, Preparation of Bill of Quantities, Specifications, Preparation of Tender Documents, Technical & Financial Evaluation of the Contractors, Top Supervision, Verifications of Materials and Equipment installed at site, Verification of Interim Payment Certificates (IPCs) of Contractor, Testing and Commissioning of System and Issuance of Completion and Commissioning Certificate HVAC system in accordance with Specifications for the following buildings: -.

- 1- New Library Building (**VRF/VRV** System)
- 2- ICT Block/Building (**VRF/VRV** System of the proposed area and **Lecture Theater** where **Package Unit** will be installed)

Sealed Technical and Financial Bids (Single Stage, Two Envelopes) on the basis of proposed area, are invited from Pakistan Engineering Council registered HVAC consultants (in relevant category) for their prequalification, having valid PEC registration for HVAC Works, and have minimum 05 years of experience in the design of Air-conditioning projects. The consultant must have completed 05 similar VRF/VRV HVAC projects worth Rs. 10 million **each** within last 5 years.

The applications should be accompanied with following documents:

- Name of the firm, address, status, telephone and fax numbers, years of experience (complete profile).
- Valid PEC registration in relevant category and valid renewal.
- NTN certificate.
- PRA Certificate
- List of permanent engineering staff.
- List of projects completed during last 05 years, with the letter from employers clearly indicating cost of projects, locations, starting & completion dates along with contact details of employers.
- Undertaking that the firm has never been blacklisted for any government or semi-government department.
- Undertaking that the firm has never been involved in litigation with any government/semi government or private department.
- Bank statement of last 3 years with minimum average balance of Rs. 1.0 Million.
- Latest Income tax return.
- Account maintenance certificate from the Bank.

NOTE:

The successful bidder has to prepare and submit RFP for Hiring of Contractor, Complete Design with BOQ and Specifications within Fifteen Days of the issuance of Work Order.

The Bids to be submitted in a sealed envelope, and should reach the office of the undersigned by **03-10-2019** (COB).
