WHEREAS, on having your absence report from the Principal, UAF Community College, PARS, disciplinary proceedings were initiated against Mr. Aftab Ahmad, Assistant Research Investigator (BPS-09) by the undersigned being Competent Authority under the provisions of the Punjab Employees Efficiency, Discipline and Accountability Act, 2006 on the charge of "Misconduct viz Misconduct viz. willful absence from the duty w.e.f. 07.11.2023" notified vide No. E-2/1751/2707-11 dated 18.03.2024. WHEREAS the Inquiry Officer submitted his report, according to which the accused was served hearing notices dated 30.08.2024, 10.09.2024 but he did not respond to any of these hearings. However, vide letter dated 24.09.024, the accused has stated that he had some domestic issues which were stressful and beyond his control so he was compelled to migrate immediately to another city and requested the Vice Chancellor to consider his earlier request to grant him leave for 730 days from 07.11.2023 to 31.10.2024. The accused further stated that he will ioin his duties on 01.11.2024 after winding up the running affairs. Accordingly, the Inquiry Officer found the accused guilty of misconduct as the aforesaid charge has been proved against him. Consequently, the Inquiry Officer recommended to impose major penalty i.e. "Removal from Service" upon him in terms of section 4(1)(b)(v) of the act ibid. WHEREAS, in order to finalize recommendations of the Inquiry Officer, a show cause-cum-personal hearing notice under section 13(4) of the PEEDA Act, 2006 was served to the accused vide No. E-2/1856/736-41 dated 29.01.2025, with the advice to appear before the Vice Chancellor on 06.02.2025 at  $03:00\,$  p.m. But due to change of chair, the said personal hearing was not materialized. AND WHEREAS, in order to meet the just cause, a show cause cum personal hearing notice was again issued to the accused under Section 13(4) of the Punjab Employees, Efficiency Discipline and Accountability Act, 2006 to appear before the Vice Chancellor on 13.06.2025 at 02:50 P.M. The accused appeared before the undersigned. The Inquiry Officer, Departmental Representative and Director, Human Resource were also present in the personal hearing meeting. NOW THEREFORE, on careful examination of the record, facts of the case, written defense submitted by the accused and hearing him in person, the undersigned being Competent Authority, by accepting the recommendations of the Inquiry Officer decided to impose major penalty of "Removal from Service" in terms of Section 4(1)(b)(v) of the Act ibid upon Mr. Aftab Ahmad, Assistant Research Investigator (BPS-09), UAF Community College, PARS, on account of "Misconduct viz. willful

absence from the duty w.e.f. 07.11.2023.
