WHEREAS, the Inquiry Officer submitted the inquiry report with following recommendations: - 5. a) "He may be imposed a minor penalty of "Censure" as provided under section 4(a) of Act abid with a strong warning to remain careful in future. b) He may be granted leave on the same terms and conditions as notified on 12.03.2025 form 08.04.2025 to 18.05.2025 during which he was absent from his duties. c) The Salary of the defendant may be started." AND WHEREAS, a show cause cum personal hearing notice was served to the defendant with the direction to appear before the Vice Chancellor on 27.06.2025 at 02:30 p.m. for personal hearing. The defendant appeared before the Vice Chancellor for personal hearing on scheduled date & time in the presence of the Inquiry Officer, Director (H.R) and Departmental Representative. However, in terms of Section 10(6) of the PEEDA, Act, 2006 the recommendation of the Inquiry Officer shall not be binding on the Competent Authority. As per findings of Inquiry Officer, the defendant remained absent from duty for 41 days (from 08.04.2025 to 18.05.2025). He resumed his duty on 19.05.2025, his joining report was forwarded by the Dean and the Director concerned. 6. NOW THEREFORE, I the Vice Chancellor being Competent Authority after perusing the Inquiry report/relevant record and hearing the defendant in person and taking lenient view, impose minor penalty of "Censure" in terms of section 4(1)(a)(i) of PEEDA, Act, 2006 upon Mr. Muhammad Younas, Lab. Technician, Institute of Horticultural Sciences. His absence period of 41 days (from 08.04.2025 to 18.05.2025), is treated as Extra Ordinary Leave (without pay and allowances).
