- 4 Preparation of Engineer's Cost Estimates for rehabilitation, improvement and Up-gradation strategy along with all human safety codes in practice (During Inspection and execution of rehabilitation and improvement works at height Approx. 55Ft)
- 5 Resident Supervision for Quality and Quantity
- 6 Verification of Interim and Final Bills.
- 7 Handing Over of completed project to Client.
- 8 Any other relevant services.

Procedure Of Selection

Single Stage-Two Envelope procedure will be adopted. Following documents in sealed envelope are required only for Eligibility / Responsiveness of Consultants. Moreover, Pre-Qualified Consultant(s) will be evaluated on the basis of PPRA Rule 45 (2) - **Least Cost Selection.**

- 1. Valid Certificate of Registration with Pakistan Engineering Council.
- 2. Valid Certificate of Registration with Council of Architects and Town Planners of Pakistan.
- 3. Copy of Registration with Securities & Exchange Commission of Pakistan OR Registrar of Firms.

- 4. Registration with Federal Bureau of Revenue (FBR).
- 5. Registration with Punjab Revenue Authority (PRA).
- 6. List of permanent professional staff along with CVs of relevant core staff showing project wise experience and qualification supported with appointment letters to authenticate the employment.
- 7. List of similar nature of works completed by the firm during last Ten (10) years including Work Orders and brief details of projects.
- 8. List of similar nature of works in hand of the firm including Work Orders and brief details of projects.
- 9. Financial position of the firm supported with authenticated financial statement(s) from financial institution / regulatory bodies, audited statements of accounts of the firm for the last Three (03) years.
- 10. Managerial capability of the firm.
- 11. Methodology to adopt for execution and completion of project.
- 12. An Affidavit on Stamp Paper of worth Rs. 100/- that the firm is not black listed by any Government, Semi Government Department and is not involved in any Litigation.
- 13. PPRA Rules 2014 (Amended To-Date) are applicable in selection process.
- 14. A pre-bid meeting to make clear understanding, visit of Iqbal Auditorium, UAF to make an appropriate proposal for rehabilitation plan will be welcomed at least seven days earlier to the tender submission date.
