#### INTRODUCTION OF THE UNIVERSITY

#### 2. ELIGIBILITY & QUALIFICATIONS

#### I. The firm has:

- a. at least 2 years experience in the relevant field;
- b. at least 2 million bank account transaction for the financial year 2014-15 (1<sup>st</sup> July 2014 to 30<sup>st</sup> June 2015);
- c. registration with FBR for Income Tax and Sales Tax and active tax payer on FBR website.
- d. registration with Punjab Revenue Authority (PRA) for services; n(for category E)
- e. filed income tax return for the tax year 2014;
- f. filed sales tax returns for the tax F.Y 2014-2015;
- g. paid professional tax for the year 2014-2015;
- h. not seen black listed in Pakistan by any government / semi-government / autonomous / semi-autonomous body / institution.
- II. Proprietor shall not be a University employee.
- III. It will be mandatory for the proprietor of the firm to appear before the committee along with authorized person for interview if the committee deems so necessary. He/she will also provide his/her specimen signature as well as of the authorized person to be duly attested by him/her before the committee to deal with the business on his/her behalf.
- IV. The proprietor and the authorized person shall render a certificate to the effect that the profession, trade or business in which his/her spouse is engaged, is in no way under his/her official influence.
- V. Good conduct of the firm for previous year if it did business with the UAF;
- VI. The firm will provide authorized distributorship / dealership / agent certificate.

#### 4. LANGUAGE OF PREQUALIFICATION APPLICATION

The Prequalification Application and all correspondence and documents related to the Prequalification Application shall be submitted in English with the exception that any pre-printed information (e.g. brochures) furnished may be written in another language, provided that it is accompanied by a certified translation of its pertinent passages in English.

#### 5. SITE VISIT

The Committee / Director (DPIC) or their representatives may visit the premises of the firm.

#### 6. PRE-QUALIFICATION FEE (NON – REFUNDABLE)

Amount = Rs.10,000/- per category

Only pre-qualified firms will be asked to deposit requisite fee for each prescribed category separately.

#### 7. BLACKLISTING & DIS-QUALIFICATION

#### BLACKLISTING

The Vice Chancellor may impose permanent or temporary bar on the supplier (s) for participation in their respective procurement proceedings who: -

- fail to perform contractual obligations or the performance under the contract is not upto the mark;
- found to be indulging in corrupt or fraudulent practices;
- commit an action causing or liable to cause loss to the University;
- furnish false information;

#### **DEREGISTRATION**

The Treasurer may deregister or impose bar on the supplier (s) for participation in procurement proceedings for the rest of the period of registration who: -

- submit bid as employee of the firm, or proprietor or shareholder being an employee of the University;
- show non-responsive attitude in case of summoning by the University.
- back out from their offers after opening of tender;
- misbehave with the University employee;

The firm may appeal to the Vice Chancellor against the decision of the Treasurer. The decision of the Vice Chancellor shall be final.

#### SETTLEMENT OF DISPUTE AND GRIEVANCES

Within seven days of receipt of the disqualification notice, the applicant may appeal against the decision of the Pre-qualification Committee to the Grievances Committee mentioned at A below. The decision of the Grievances Committee shall be final.
